FIRE PROTECTION IN MARINA LAV

Taking care of safety of people in the marina as well of the property they have entrusted to the marina for safekeeping is primary task of Grand Hotel LAV.

Vessel owner is obliged to equip the vessel with fire protection equipment that will provide effective protection for the vessel, but each vessel must also have at least one automatic fire extinguishing system in the engine compartment.

A prerequisite for safety of the vessels in the marina is maintaining technological order and cleanliness in the marina as well as on its passages and on the vessels.

Accessing piers (quays, wharves) must be enabled at all times and passages must be designed for the firefighting equipment of the marina and the equipment of the firefighting units to be used as effectively as possible.

It is strictly forbidden performing actions on the vessel that include: use of open flames, welding, soldering, cutting, sanding, stripping paint and painting, and all the actions that tend to: create excessive noise, heat vessel surface or its parts, create combustible dust or cause evaporation of flammable liquids.

While performing any actions on the vessel one must follow basic fire protection measures and arrange temporary working place on the vessel in a way for it to reduce the risks from starting the fire, and equip the place with fire extinguishers.

Storing batteries and charging them with electrolytes is strictly forbidden.

It is forbidden to charge and supply vessels with fuel and gas in the marina.

It is possible to make an exception based on a written request explaining the situation. In that case, the person in charge of fire protection can issue a permit, ordering all precautions, location and manner of conducting the procedure.

DUTIES AND OBLIGATIONS IN CASE OF FIRE

Anyone who notices the risk of fire or the fire itself, is obliged to eliminate the danger by extinguishing the fire, if it is possible that the person does it himself, and without endangering himself or others.

If that person cannot do it himself, he/she is obliged to immediately call for help from other employees and notify the marina reception about the fire (or the fire department if for some reason the reception cannot receive the information).

When notifying about the fire one must enable the following informations:

- place (location) of the fire
- type of material that is burning
- is the fire happening on an open or closed area
- are there any casualties (it is ok to enable this information afterwards)
- name and surname of the person who is notifying about the fire

Before the fire department unit or a highly ranked employee (marina manager) arrives to the site, the employee who started extinguishing the fire first, takes over the process of extinguishing the fire, while making sure not to expose himself and/or others to the unnecessary danger.

Leader of the fire extinguishing action is obliged to ensure that all available resources and fire extinguishers are brought to the site, while also making sure that other objects (including vessels) that might be damaged during fire are safely removed..

It is important that only necessary staff is on the site of the fire, while others should be evacuated or safely distanced from the site. It is necessary to inform the person in charge of fire protection in the marina about the situation.

After the fire has been put out, it is necessary that the person in charge of fire protection in the marina together with the marina manager does the following actions:

- provide a person on duty during the required period of time to prevent the fire from starting again;
- provide an on-call duty at the site of the fire until the next day, if the fire was extinguished during the night;
- make sure that the person on duty has all the necessary equipment for fire extinguishing.

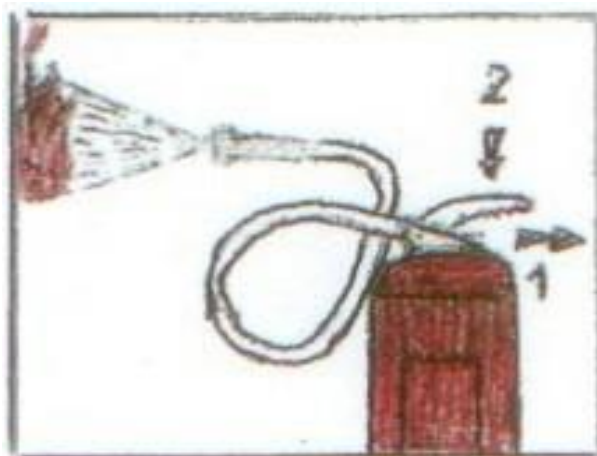
There is a 24-hour surveillance of the marina by sailors on duty. All the employees are obliged, within their work tasks to monitor the marina for possible occurrence of fire.

INSTRUCTIONS FOR USING FIRE EXTINGUISHING EQUIPMENT IN MARINA LAV

A) FIRE EXTINGUISHER USING DUST „S“, type S 6 kg



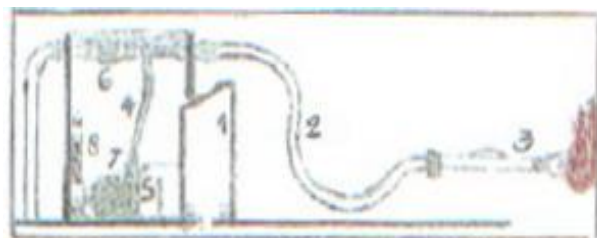
- Pull the safety pin (1)
- Press the lid lever (2) to its maximum and release it fast
- Wait for five seconds
- Press the lid lever again

B) FIRE EXTINGUISHER USING DUST S, type S 50 kg




- Lower the front part of the extinguisher (1)
- Release the hose and level it with the nozzle (2)
- Remove the safety pin and rotate the valve lever (3)
- Pull the nozzle cap (4)

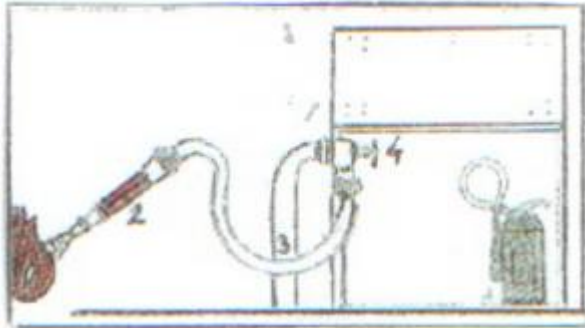
C) HYDRANT CABINETS WITH EQUIPMENT FOR EXTINGUISHING FIRE WITH FOAM



- Open the cabinet door (1)
- Roll out the hose (2) and connect the nozzle
- Immerse the plastic tube (4) into the foam (5)
- Open the valve (6) to its maximum
- If necessary, use the extension hose(7) and the nozzle (8)
